

Food Assistance Replacement Benefits June 2022 Outages FAQs

Background

If you receive SNAP and lost food during the power outages June 14 - 16, you are eligible
for Food Assistance Replacement Benefits. Replacement benefits work just like your
regular benefits. They will be uploaded directly to your EBT/Ohio Direction card and can be
used on the same eligible food items.

Who is Eligible?

 In order to qualify, your household must be currently receiving SNAP benefits (i.e., have received SNAP benefits in the month of June) and have lost power for at least 4 hours last week.

How much assistance can I request?

You can request replacement benefits for the amount of all food that was lost, so long as it
 does not exceed your monthly allotment. For instance, if your family received \$246* in food
 assistance this month, you could request up to \$246 dollars.
 *Average monthly issuance

How do I apply?

- Visit https://jfs.franklincountyohio.gov/food-assistance-replacement-benefits to download an application (translations available for Arabic, Somali and Spanish).
- The applications need to be submitted within 10 days of the food loss. However, since there were rolling blackouts throughout the week, Franklin County will be accepting applications through this upcoming Monday, June 27.

Do I need to provide verifications?

 If you have a notification (example: text message or email from AEP), you are welcome to include that with your application, however Franklin County JFS will be verifying eligibility based off outage data provided by AEP, including impacted ZIP codes.

How long until I receive my replacement benefits?

- Franklin County JFS has up to 10 days to from the day we receive an application to process it, however we are processing as quickly as we can and have approved many within 48 hours.
- You will receive a letter in the mail when your application has been approved and your replacement benefits have been uploaded. However, we encourage you to check your EBT/Ohio Direction card balance as well since replacement benefits may be uploaded before you receive a letter.
